ORDINANCE NO. 16-001

AN ORDINANCE REQUESTING TAX ROLL FOR THE CITY OF NEW BERLIN, TEXAS, FOR THE PURPOSE OF SETTING A TAX RATE TO THE PLANNED EXPENSES OF THE CITY FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2017.

WHEREAS, the City of New Berlin, Texas anticipates the levy of an ad valorem tax on all taxable property in the City of New Berlin; and

WHEREAS' the Chief Appraiser of Guadalupe County Tax Appraisal District can prepare the appraisal roll for the City of New Berlin, Texas, that roll being that portion of the approved appraisal roll of the Guadalupe County Tax Appraisal District which lists property taxable by the City of New Berlin, Texas; and

WHEREAS, the City of New Berlin has not yet levied an Ad Valorem tax; and

WHEREAS, the City will fully and timely comply with all notice and other requirements relative to the adoption of a tax rate for FY 2017.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEW BERLIN, TEXAS, THAT:

Section 1. There is hereby requested a certified tax roll from the Guadalupe County Appraiser effective date of January 1, 2017.

Section 2. The City of New Berlin will pay an allocation fee based on the appraised value of property included in the requested tax roll.

Section 3. Should any paragraph, sentence, provision, clause, phrase or section of this Ordinance be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this Ordinance, as a whole or any part or provision thereof, other than the part or parts adjudged to be invalid, illegal, or unconstitutional.

Section 4. This ordinance shall be in full force and effect from and after its adoption by the City Council.

Section 5. All other ordinances and Code provisions in conflict herewith are hereby repealed, but only to the extent of any such conflict or inconsistency and all other provisions of the New Berlin City Code not in conflict herewith shall remain in full force and effect.

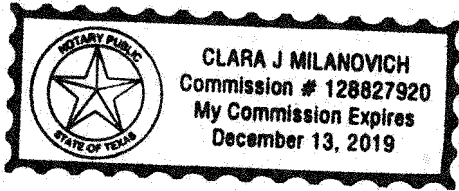
