





ORDINANCE NO. 2019-005: ANNEXING BROWN TERRITORY

AN ORDINANCE ANNEXING THE HEREINAFTER DESCRIBED TERRITORY TO THE CITY OF NEW BERLIN, GUADALUPE COUNTY, TEXAS, AND EXTENDING THE BOUNDARY LIMITS OF SAID CITY SO AS TO INCLUDE SAID HEREINAFTER DESCRIBED PROPERTY WITHIN SAID CITY LIMITS, AND GRANTING TO ALL THE INHABITANTS OF SAID PROPERTY ALL THE RIGHTS AND PRIVILEGES OF OTHER CITIZENS AND BINDING SAID INHABITANTS BY ALL OF THE ACTS, ORDINANCES, RESOLUTIONS, AND REGULATIONS OF SAID CITY.

WHEREAS, pursuant to Chapter 43 of the Texas Local Government Code of the City of New Berlin, Texas, an incorporated city, authorizes the annexation of territory, subject to the laws of this state; and

WHEREAS, the procedures prescribed by the Texas Local Government Code of the City of New Berlin, Texas, and the laws of this state have been duly followed with respect to the following described territory, currently fully located within the Extraterritorial Jurisdiction of the City of New Berlin to wit: particularly described in Exhibit A (pages A1-A5) attached hereto.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEW BERLIN, TEXAS:

That the heretofore described property is hereby annexed to the City of New Berlin, Guadalupe County, Texas, and that the boundary limits of the City of New Berlin be and the same are hereby extended to include the above described territory within the city limits of the City of New Berlin, and the same shall hereafter be included within the territorial limits of said city, and the inhabitants thereof shall hereafter be entitled to all the rights and privileges of other citizens of the City of New Berlin and they shall be bound by the acts, ordinances, resolutions, and regulations of said city.

The City Secretary is hereby directed to file with the County Clerk of Guadalupe, Texas, a certified copy of this ordinance.

PURSUANT TO SECTION 43.028 THE TEXAS LOCAL GOVERNMENT CODE:

TO: THE MAYOR AND GOVERNING BODY OF THE CITY OF NEW BERLIN, TEXAS:

The undersigned owner(s) of the hereinafter described tract of land which is (1) one-half mile or less in width, (2) contiguous to the City of New Berlin, Texas, (3) vacant and without residents, or on which less than three (3) qualified voters reside, and (4) not within the extraterritorial jurisdiction of any other municipality, hereby petition your Honorable body to extend the present City limits so as to include and annex as a part of the City of New Berlin, Texas, the following described property, which is additionally detailed in Exhibit "A", attached hereto and made a part hereof, to wit:

233.30 acres, lying in the Vicente Gortari Survey, Abstract 24, Guadalupe County, Texas and being more particularly described by metes and bounds in Exhibit A



233.30 ACRE TRACT NEW BERLIN, TEXAS



A tract of land containing 230.30 acres, lying in the Vicente Gortari Survey, Abstract No. 24, Guadalupe County, Texas, and being a conglomeration of a 13.030 acre tract of land, described in a instrument recorded in Volume 1683, Page 521 of the Official Public Records of Guadalupe County, Texas, a 34.875 acre tract of land, and a 85.425 acre tract of land, described in a instrument recorded in Volume 1684, Page 358 of the Official Public Records of Guadalupe County, Texas, and a 100.00 acre tract of land, described in a instrument recorded in Volume 2023, Page 0263 of the Official Public Records of Guadalupe County, Texas, said tract of land being more particularly described by metes and bounds as follows:

Beginning at a point marked by a steel rod monument, found for the North corner of said 100.00 acre tract of land, lying on the Southwest right-of-way line of Santa Clara Road, and the East corner of a 1.00 acre tract of land, described in a instrument recorded in Volume 4154, Page 0369 of the Official Public Records of Guadalupe County, Texas, said point of beginning being the Northeast corner of this tract of land;

Thence along the Northeast line of said 100.00 acre tract of land, 85.425 acre tract of land, 12.53 acre tract of land, and a 34.875 acre tract of land, being the Southwest line of Santa Clara Road the following bearings and distances:

Thence South 23° 47′ 40" East, 1078.84 feet, to a steel rod monument, found for the East corner of said 34.875 acre tract of land, being the North corner of a 9.50 acre tract of land, described in a instrument recorded in Volume 632, Page 65762 of the Official Public Records of Guadalupe County, Texas, said point being the East corner of this tract;

Thence South 59° 31' 23" West, 2985.03 feet, along the Southeast line of said 34.875 acre tract of land, 12.53 acre tract of land, and a 85.425 acre tract of land, being the Northwest line of said 9.50 acre tract of land, and a 79.358 acre tract of land, described in GCADD Parcel No. 57405, to a steel rod monument, found for the South corner of said 85.425 acre tract of land, being the East corner of a 217.36 acre tract of land, described in a instrument recorded in Volume 1709, Page 0806 of the Official Public Records of Guadalupe County, Texas, said point being the South corner of this tract;

Thence North 29° 13' 08" West, 3306.36 feet, along the Southwest line of said 85.425 acre tract of land, and 100.00 acre tract of land, being the Northeast line of said 217.36 acre tract of land, to a steel rod monument, found for the West corner of said 100.00 acre tract of land, being the North corner of said 217.36 acre tract of land, lying of a 137.21 acre tract of land, described in a instrument recorded in Volume 2016, Page 7144 of the Official Public Records of Guadalupe County, Texas, said point being the West corner of this tract;

Thence North 59° 48' 42" East, 2879.95 feet, along the Northwest line of said 100.00 acre tract of land, being the Southeast line of said 137.21 acre tract of land, and a 33.582 acre tract of land, described in a instrument recorded in Volume 2704, Page 266 of the Official Public Records of Guadalupe County, Texas, and a 13.00 acre tract of land, described in a instrument recorded in Volume 2016, Page 25580 of the Official Public Records of Guadalupe County, Texas, to a steel rod monument, found for the South corner of said 1.00 acre tract of land, said point being an angle point of this tract;

Thence North 61° 06' 05" East, 240.59 feet, along said Northwest line of said 100.00 acre tract of land, being the Southeast line of said 1.00 acre tract of land, to the point of beginning;
