

ORDINANCE NO. 2020-005

A RESOLUTION OF THE CANVASS AND CERTIFICATION AS TO THE RESULT OF THE SPECIAL ELECTION IN THE CITY OF NEW BERLIN, TEXAS, GUADALUPE COUNTY, HELD ON TUESDAY, NOVEMBER 03, 2020.

WHEREAS, the city council and mayor of the city of New Berlin resolved and ordered a special election to be held on November 03, 2020 in the city of New Berlin, Texas for the purpose of adopting the following proposition:

"The abolishment of the prior sales and use tax first adopted in 2014 for the maintenance and repair of municipal streets, and the adoption of a general local sales and use tax in the city of New Berlin at a rate of one and one-half  $(1 \frac{1}{2})$  percent."; and

WHEREAS, it appearing from said returns, duly and legally made, that there was cast at said special election 474 valid and legal votes; and

WHEREAS, that the proposition considered in said election, received the votes as follows:

WHEREAS, council member <u>Michael V. Hale</u> moved adoption of this Resolution herein set forth, with the motion being seconded by council member <u>Teffrey S. Schlichting</u> and the Resolution being adopted unanimously in the form of this Ordinance No. 2020-005.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NEW BERLIN, TEXAS:

**SECTION 1:** That said Special Election of the city of New Berlin, held on the 3<sup>rd</sup> day of November, 2020, was duly called, that notice of said Special Election was given, and that said Special Election was held in accordance with the laws of Texas.

**SECTION 2:** That the following ballot proposition received **288** votes **for** the proposition and **186** votes **against** the proposition; the number of votes by which the proposition was **approved** by was **102** votes; and, therefore the below proposition was approved by the voters:

"The abolishment of the prior sales and use tax first adopted in 2014 for the maintenance and repair of municipal streets, and the adoption of a general local sales and use tax in the city of New Berlin at a rate of one and one-half  $(1 \frac{1}{2})$  percent."

**PASSED AND ADOPTED** this, the 14th day of December, 2020, by the city council of the city of New Berlin, Texas.
